Prop 2	State of California AUTHORIZES BONDS FOR PUBLIC SCHOOL AND COMMUNITY COLLEGE FACILITIES: Authorizes state to issue \$10,000,000,000 in bonds for school facilities to construct and modernize education facilities.	NO	Mega-bond alert! Worse yet, this brings all school buildings under state control , instead of local school district control. Schools must conform to be funded.
Prop 3	State of California CONSTITUTIONAL RIGHT TO MARRIAGE: Updates California constitution, Article I, Section 7.5: "The right to marry is a fundamental right."	NO	Now my son really can marry his dog! How many parties can be in one marriage? Child marriage?
Prop 4	State of California AUTHORIZES BONDS FOR SAFE DRINKING WATER, WILDFIRE PREVENTION, AND PROTECTING COMMUNITIES AND NATURAL LANDS FROM CLIMATE RISKS: Authorizes state to take out \$10,000,000,000 in bonds.	NO	The fine print: "Bonds...may be issued...for carrying out the purposes expressed in this division and to reimburse the General Obligation Bond Expense Revolving Fund... "
Prop 5	State of California ALLOWS LOCAL BONDS FOR AFFORDABLE HOUSING AND PUBLIC INFRASTRUCTURE WITH 55% VOTER APPROVAL: Lowers approval for local tax and bond initiatives from 2/3 of the vote down to 55% of the vote.	NO	This is a direct attack on Proposition 13. If Prop 5 is not stopped, property tax bills are likely to go up after every single election, forever.
Prop 6	State of California ELIMINATES CONSTITUTIONAL PROVISION ALLOWING INVOLUNTARY SERVITUDE FOR INCARCERATED PERSONS: Prohibits Dept of Corrections and Rehabilitation from disciplining any incarcerated person for refusing a work assignment.	NO	Many incarcerated individuals have lost their way and need discipline. This would increase the cost to society of incarceration because new hiring or prisoner labor negotiations would be required.
Prop 32	State of California RAISES MINIMUM WAGE: Raises minimum wage from \$15 to \$18/hr (increasing \$1 per year until \$18/hr), thereafter adjusting for inflation.	NO	Raising minimum wage decreases available hours for workers. Better to increase wages by not forcing businesses out of the state or out of business.
Prop 33	State of California EXPANDS LOCAL GOVERNMENTS' AUTHORITY TO ENACT RENT CONTROL ON RESIDENTIAL PROPERTY: Current state law prohibits cities and counties from enacting rent control. This measure would repeal that and allow local municipalities to enact local ordinances.	NO	Will lead to a sharp reduction in new apartment construction as lenders evaluate financial risk, worsening our housing shortage. Voters rejected this proposal twice, 2018 and 2020.

Prop 34	State of California RESTRICTS SPENDING OF PRESCRIPTION DRUG REVENUES BY CERTAIN HEALTH CARE PROVIDERS: Any health care drug retailer who has invested over \$100,000,000 in multifamily housing and received over 500 health and safety violations must spend 98% of profits on patient care.	NO	"Revenge Initiative" applies only to Michael Weinstein, who angered the CA Apartment Assn (who funded this prop) because he's funded 3 rent control initiatives, including Prop 33 on this ballot.
Prop 35	State of California PROVIDES PERMANENT FUNDING FOR MEDI-CAL HEALTH CARE SERVICES: Makes permanent existing tax on health care plans, currently set to expire in 2026. State uses this tax to pay for health care services for low-income families and "other groups" covered by Medi-Cal program.	NO	This makes permanent a tax on insurance companies that is used to pay for individuals on Medi-Cal, including the newly covered illegal immigrants.
Prop 36	State of California ALLOWS FELONY CHARGES AND INCREASES SENTENCES FOR CERTAIN DRUG AND THEFT CRIMES: Repeals parts of Prop 47.	YES	Aimed at stopping surge of retail theft, vehicle break-ins and open drug use on California's streets.
Measure A	Morgan Hill City Measure limits mayoral, city council, and treasurer terms of cumulative service to twelve consecutive years, with eligibility for reelection	No Reco	
Measure B	City of Morgan Hill Measure changes mayoral term from two years to four years	No Reco	
Measure C	City of Gilroy Adds 0.25% sales tax for public safety (police, fire and ambulance) services and public safety infrastructure projects	NO	Called "Public Safety Tax", requires 2/3 vote.
Measure D	City of Palo Alto Measure to undedicate 0.33-acre portion of El Camino Park to create new road linking Transit Center with El Camino Real to reduce traffic	No Reco	
Measure E	City of Sunnyvale Bond measure authorizing \$290,000,000 to update and enlarge Main Library	NO	Bond alert! \$525/yr on average home (25-yrs). If ACA1 passes, only requires 55% vote instead of 2/3.
Measure F	City of Sunnyvale Charter Amendment to (1) eliminate citizenship requirement for boards and commissions; (2) change Council meeting frequency; and (3) replace gendered references in charter	NO	NO, whatever, and go away! Curious that they couch (1) with the other more palatable issues.
Measure G	City of Mountain View Property transfer tax on residential/commercial property sales over \$6,000,000 for municipal improvements	NO	Another "tax the rich" that filters down to the not rich. \$15/\$100,000 of sale price, no sunset.
Measure I	City of Santa Clara Bond measure authorizing \$400,000,000 for 911, potholes, storm drains, a variety of rec, library, & other facilities	NO	Bond alert! \$323/yr on average home (36-yrs). If ACA1 passes, only requires 55% vote instead of 2/3.
